A complete set of Bidding Documents may be purchased from the office Patan Academy of Health Sciences, Lagankhel, Lalitpur by eligible Bidders on the submission of a written application, along with the copy of company/firm registration certificate and upon payment of a non-refundable fee of NPR 10,000.00 till November 06, 2017. If so requested, the Bidding Documents can also be sent by post/courier services upon payment of additional cost of NPR 7000.00. However, the Employer will not be responsible for delay or non-delivery of the documents so sent.
- 5. Pre-bid meeting shall be held at Office of Registrar, Patan Academy of Health Sciences, Lagankhel, Lalitpur at 11:30 on October 29, 2017.
- 6. Sealed bids must be submitted to the Office of Registrar, Patan Academy of Health Sciences, Lagankhel, Lalitpur by hand/courier on or before 12:00 noon, November 06, 2017. Bids received after this deadline will be rejected.
- 7. The bids will be opened in the presence of Bidders' representatives who choose to attend at **14:00 hrs**, **November 06**, **2017** at the Office of Registrar. Bids must be valid for a period of **90 days** after bid opening and must be accompanied by a bid security amounting to a minimum of 2.5%, which shall be valid for **30 days** beyond the validity period of the bid.
- 8. If the last date of purchasing and /or submission falls on a Government and PAHS holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
- 9. In the case of discrepancies or error in bid documents, bid notice or any other documents as required, PAHS reserves the right to amend and correct as required.
- 10. PAHS reserve the right to accept or reject, wholly or partially any or all the bids without assigning reason, whatsoever.
